If any indebtedness is placed in the hands of attorney for collections or is collected by suit or through probate or bankruptcy proceedings, the Customer agrees to pay all costs, interest at 1-1/2% per month on the outstanding amount plus the actual amount for attorney's fees.

Customer affirms that it is financially able to meet commitments it has made and expects to pay invoices in accordance with terms as specified.
